#### **Evaluation of products**

An hourly rate of € 99,- will be charged for the evaluation of newly submitted products, depending on the work involved. If the documents are complete, you can expect the assessment to take 1 - 2 hours. In the event of queries, clarifications, etc., the time required and therefore the number of hours charged will increase.

The actual processing time also depends on how many products we are working on. We evaluate the products in the order in which they are registered.

#### **Listing of products**

Products are listed by January 31<sup>st</sup> of the following year. The advertising tax for listing products in the printed inputs catalogue is 5% and must be collected by us and paid to the tax office.
